### **ASSOCIATE IN APPLIED SCIENCE**



The sequencing of courses in this program begins in the first seven-week fall semester online. Students entering the program in the spring or summer may take longer than two years to complete the degree.

#### **Program Description**

The Associates in Applied Science Forensic Social Work is an interdisciplinary program which prepares students for careers focused on the intersection between the human service and legal systems. Areas of study include crisis intervention, cross-cultural competency, advocacy, court mandated treatment, community relations, legal systems, social justice, and trauma-informed service provision. The National Advocate Credentialing Program (NACP) certificate is embedded into the degree requirements.

#### **Program Learning Outcomes**

Students who successfully complete the Associates in Forensic Social Work track will be able to:

- Demonstrate awareness of, and respect for, diverse populations and develop a culturally responsive communication style.
- Engage in treatment service provision including crisis intervention, evaluation, diagnosis, and referral.
- Articulate an understanding of the role and function of both the criminal and civil court systems.
- Utilize skills that will assist in consultation, support, and collaboration with professionals in both the human service and criminal justice fields.
- Provide advocacy services across a range of domains related to both criminal and civil issues.



#### **Career Opportunities**

Graduates of this program may pursue careers related to corrections, advocacy, child protection, probation, arbitration, and mediation. The program also provides a strong foundation for students who wish to pursue a bachelor's degree.

Articulation agreements exist between York County Community College and various colleges and universities.
